At the 72nd Ave Recovery Center, we are here to help you find relief from distress and assist you in creating a foundation for recovery.

Although we are a locked facility, our staff will work with you during your stay to make sure that you feel respected and supported in making positive life choices.

Services at 72nd Ave Recovery Center

Services include, but are not limited to:

- Individual psychotherapy
- Medication management
- Group activities
- Skill building groups
- Milieu therapy
- Community integration activities
- Case management from an external service provider

Becoming a Resident

Referrals to the program are made by the Multnomah County Human Services Department (Mental Health Division). Prospective applicants are either in one of the three Oregon State Hospitals or from a variety of local acute Care psychiatric units.

A screening is scheduled and the prospective applicant is interviewed to determine their suitability for admission into the program. Once completed, the applicant and referral source will be contacted with either an acceptance or denial decision. The denial will have a justification for this decision.

Admission Criteria

Adult males 18 years and older, who have a primary psychiatric diagnosis of Axis I and who have had extensive institutional experiences.

Our Story

Developed in partnership with the State of Oregon Office of Mental Health and Addiction Services, the 72nd Ave Recovery Center offers a clinical approach that is dramatically different than the traditional sub-acute locked facility. The program embraces the recovery philosophy at all levels instead of focusing primarily on symptom and behavior management. Recovery is woven into and defines every aspect of the program, from assessments and interventions to the resident information system, the selection of staff, and the overall resident experience.

This program is funded by Medicare, Medicaid, Oregon Office of Mental Health and SSI.
