Telecare's Recovery Culture

Telecare's services are strength-based, person-centered, with a focus on wellness and recovery. Services are designed using Telecare's Recovery-Centered Clinical System (RCCS). This system incorporates evidence-based practices and innovative design components, and emphasizes choice-making skills and harm-reduction techniques, and strives to awaken the hopes and dreams of the individual.

Staffing & Services

We have a multidisciplinary team of nurses, social workers, clinicians, and peer staff. Services include:

- Access to behavioral health services
- Access to primary care
- Access to specialty prescribing care
- Access to medical insurance
- Developing effective self-care
- Application for various benefits
- · Access to education, work, and training
- Housing advocacy and referrals
- Referrals and support to address substance use issues

Admission Criteria

- Adults, ages 18 and older
- Residents of Thurston and Mason counties
- Those transitioning from inpatient psychiatric settings, emergency departments, or residential treatment
- Individuals that are currently in or qualify for community-based services (excluding PACT)
- Individuals that need to be linked with outpatient services



Hospital Diversion Services

- Available at all county emergency rooms

T-CAT and emergency room staff partner closely together to offer safe alternatives for adults who are at risk of inpatient hospitalization due to mental health challenges, but who may remain in a community setting with additional support.
