At La Luz Assertive Community Treatment (ACT), we are here to help you find relief from distress and assist you in maintaining stability in your life.

## **Accessing Services**

This program has a closed referral process and does not take referrals from the community. Referrals must be living in a county-approved long term care facility and be within 90 days of discharge. Referrals can be made directly from long term care facilities or County Institutional Case Management via Telecare In-Reach. Referrals can be emailed to SD\_ReferralCenter@optum.com.

### **Admission Criteria**

Adults who are homeless with a serious mental illness who may have a co-occurring substance use disorder, are not connected to outpatient services and are in long-term care facilities (LTC), and will be discharged as a step-down in to the community.
